However, as banks diversify and demonstrate improved profitability in non-interest income segments, there has been some upward movement in P/E ratios, albeit still generally lower than their international peers. Analysts scrutinize the sustainability of these earnings when assessing P/E ratios.

Dividend Yields and Shareholder Returns
