Characteristics of Sound Waves

1. **Frequency:** Measured in Hertz (Hz), frequency refers to the number of complete oscillations a wave makes per second. It is perceived by humans as **pitch**. Higher frequencies correspond to higher pitches (e.g., a soprano singer), while lower frequencies correspond to lower pitches (e.g., a bass drum). Wavelength is inversely proportional to frequency; higher frequency waves have shorter wavelengths, and vice versa. The relationship between speed of sound (v), frequency (f), and wavelength (λ) is given by the fundamental wave equation: $v = f\lambda$.
4. **Speed of Sound:** The speed at which a sound wave travels through a medium. This speed is dependent on the properties of the medium, specifically its elasticity and density. Sound travels faster in denser and more elastic materials. For instance, the speed of sound in air at room temperature is approximately 343 meters per second, while it travels much faster in water (around 1480 m/s) and even faster in solids like steel (around 5960 m/s).
5. **Timbre (Tone Quality):** This characteristic distinguishes two sounds of the same pitch and loudness. Timbre is determined by the complex mixture of fundamental frequency and its overtones (harmonics). It's what allows us to differentiate between a violin and a piano playing the same note.

1. **Reflection:** When a sound wave encounters a surface, it bounces back. This is responsible for echoes, where a sound is reflected off a distant surface and heard again. The angle of incidence equals the angle of reflection, a principle vital in architectural acoustics.
2. **Refraction:** The bending of sound waves as they pass from one medium to another or through regions of varying temperature or wind. This can affect how sound travels over distances, particularly outdoors.
3. **Diffraction:** The ability of sound waves to bend around obstacles or spread out after passing through openings. This is why we can hear sounds around corners.
4. **Interference:** When two or more sound waves meet, their amplitudes can add up (constructive interference, leading to louder sound) or cancel each other out (destructive interference, leading to quieter sound). This phenomenon is exploited in noise-canceling technologies.
5. **Absorption:** When sound waves strike a material, some of their energy is converted into heat. This process is known as absorption, and its effectiveness is measured by the **sound absorption coefficient** of a material. Soft, porous materials like foam and fabric are good sound absorbers.
