- * **The Spanish-American War:** This brief conflict, sparked by the sinking of the USS Maine, saw the United States emerge as a global power. The U.S. acquired Cuba, Puerto Rico, Guam, and the Philippines from Spain for \$20 million in the Treaty of Paris (1898). The annexation was not a foregone conclusion for many Filipinos. Aguinaldo had declared Philippine independence in June 1898, prior to the Treaty of

Paris, and expected American recognition. However, the U.S. government ultimately chose to acquire the islands, leading to the brutal Philippine-American War (1899-1902), a conflict often overlooked in favor of the Spanish-American War.

The Legacy of Annexation and its Relevance Today

Understanding the Philippines annexation mini DBQ is not merely an academic exercise. The historical events have profound and lasting implications:

- * **Philippine Identity:** The struggle against colonial powers has shaped Filipino national identity and its ongoing pursuit of full sovereignty.

- * **Global Imperialism Debates:** The annexation remains a touchstone for discussions about the ethics and consequences of international intervention and the role of powerful nations on the global stage.
