2. **Access Reset Options:** Click the Start button, then Settings (gear icon). Go to Update & Security (Windows 10) or System > Recovery (Windows 11).
3. **Choose "Reset this PC":** Click on "Get started" under "Reset this PC."
4. **Select an Option:** You'll be presented with two choices:
 1. **Keep my files:** This removes apps and settings but keeps your personal files. It's not a true factory reset in the sense of wiping everything.
 2. **Remove everything:** This removes all personal files, apps, and settings, returning your PC to its factory state. Choose this for a full reset.
5. **Choose Reinstallation Method:** You'll then be asked whether to use Cloud Download (requires internet) or Local Reinstall. Cloud Download often provides a cleaner, more up-to-date installation.
6. **Confirm and Reset:** Follow the on-screen prompts to confirm your choices. Your PC will restart and begin the reset process.

Restoring a Mac

For Macs, the process involves using macOS Recovery.

Your Mac will download and install a fresh copy of macOS.

Software Glitches After Reset

While rare, sometimes a factory reset doesn't resolve the underlying issue, or new glitches can appear due to driver incompatibilities or hardware problems that the reset couldn't fix.
