$-\infty$). However, if we are considering the area of a square with side length x , then the explicit domain for x would be $[0, \infty)$, as side lengths cannot be negative.

Why is the Domain Important?

5. **Function Composition:** When composing functions (e.g., $f(g(x))$), the domain of the inner function $g(x)$ must be considered, and its output must also be within the domain of the outer function $f(x)$.
