This indeterminate form allows us to use L'Hôpital's Rule, a powerful technique for evaluating limits of fractions that result in indeterminate forms. This rule states that if $\lim_{x \rightarrow c} \frac{f(x)}{g(x)}$ results in $\frac{0}{0}$ or $\frac{\infty}{\infty}$, then the limit is equal to $\lim_{x \rightarrow c} \frac{f'(x)}{g'(x)}$, provided the latter limit exists.

Solution:

1. Identify $f(x)$ and $g(x)$: Here, $f(x) = \sin(x)$ and $g(x) = x$.
2. Find the derivatives: $f'(x) = \cos(x)$ and $g'(x) = 1$.
3. Apply L'Hôpital's Rule: We evaluate the limit of the ratio of the derivatives: $\lim_{x \rightarrow 0} \frac{\cos(x)}{1}$.
4. Evaluate the new limit: Substituting $x = 0$ into $\cos(x)$ gives $\cos(0) = 1$.

Answer: The limit is 1.

Mastering Derivatives: The Essence of Instantaneous Change

Derivatives are arguably the most iconic concept in calculus. They measure the instantaneous rate of change of a function, providing insights into slopes of tangent lines, velocities, and acceleration. Understanding derivative rules and applications is fundamental to solving a wide array of calculus problems.

Understanding Derivatives: The Power Rule and Beyond

The power rule is a cornerstone for differentiating polynomial functions. For a function of the form $f(x) = ax^n$, its derivative is $f'(x) = n \cdot ax^{n-1}$. Other crucial rules include the product rule, quotient rule, and chain rule, essential for differentiating more complex functions.

Example 3: Applying the Power Rule and Sum/Difference Rule

Problem: Find the derivative of $f(x) = 3x^4 - 2x^3 + 5x - 7$.

Analysis: This problem requires the application of the power rule to each term and the sum/difference rule, which states that the derivative of a sum or difference of functions is the sum or difference of their derivatives. The derivative of a constant is zero.

Solution:

1. Apply the power rule to each term:
 1. Derivative of $(3x^4)$: $(4 \cdot 3x^{4-1} = 12x^3)$
 2. Derivative of $(-2x^3)$: $(3 \cdot (-2)x^{3-1} = -6x^2)$
 3. Derivative of $(5x)$: $(1 \cdot 5x^{1-1} = 5x^0 = 5)$
 4. Derivative of (-7) : (0)

2. Combine the derivatives of each term:

$$f'(x) = 12x^3 - 6x^2 + 5 - 0$$

Answer: $f'(x) = 12x^3 - 6x^2 + 5$

Example 4: Using the Product Rule

Problem: Find the derivative of $g(x) = (x^2 + 1)(e^x)$.

Analysis: This function is a product of two simpler functions, $u(x) = x^2 + 1$ and $v(x) = e^x$. The product rule states that if $h(x) = u(x)v(x)$, then $h'(x) = u'(x)v(x) + u(x)v'(x)$. We will need to find the derivatives of $u(x)$ and $v(x)$.

Solution:

1. Identify $u(x)$ and $v(x)$: $u(x) = x^2 + 1$, $v(x) = e^x$.
2. Find their derivatives:
 1. $u'(x) = 2x$ (using the power rule and constant rule)
 2. $v'(x) = e^x$ (the derivative of e^x is itself)
3. Apply the product rule formula:

$$g'(x) = (2x)(e^x) + (x^2 + 1)(e^x)$$

4. Simplify the expression (optional but good practice):

$$g'(x) = e^x(2x + x^2 + 1) = e^x(x^2 + 2x + 1) = e^x(x + 1)^2$$

Answer: $g'(x) = e^x(x + 1)^2$

Example 5: Applying the Chain Rule

Problem: Find the derivative of $h(x) = \sin(3x^2)$.

Analysis: This is a composite function, meaning one function is "inside" another. Here, the outer function is $\sin(u)$ and the inner function is $u = 3x^2$. The chain rule is used for differentiating composite functions: if $y = f(g(x))$, then $y' = f'(g(x)) \cdot g'(x)$. This rule is fundamental for understanding complex derivative calculations.

Solution:

1. Identify the outer and inner functions:

1. Outer function: $f(u) = \sin(u)$, so $f'(u) = \cos(u)$.
2. Inner function: $g(x) = 3x^2$, so $g'(x) = 6x$.
2. Apply the chain rule:

$$h'(x) = f'(g(x)) \cdot g'(x) = \cos(3x^2) \cdot (6x)$$

3. Rewrite in standard form:

$$h'(x) = 6x \cos(3x^2)$$

Answer: $h'(x) = 6x \cos(3x^2)$

The Power of Integration: Accumulating Change

Integration is the inverse operation of differentiation. It's used to find areas under curves, volumes of solids, and to accumulate quantities over intervals. Understanding indefinite and definite integrals is crucial for solving many application-based calculus problems.

Indefinite Integrals: Finding Antiderivatives

An indefinite integral of a function $f(x)$ is a family of functions whose derivative is $f(x)$. It is denoted by $\int f(x) \, dx$. Remember to always add the constant of integration, $+ C$, because the derivative of a constant is zero.

Example 6: Basic Integration using the Power Rule for Integration

Problem: Find the indefinite integral of $f(x) = 5x^2 + \sqrt{x} - \frac{1}{x^3}$.

Analysis: This problem requires rewriting the terms in power form (x^n) and then applying the power rule for integration: $\int x^n \, dx = \frac{x^{n+1}}{n+1} + C$ (for $n \neq -1$). The integral of $\frac{1}{x}$ is $\ln|x| + C$.

Solution:

1. Rewrite the function in power form:

$$f(x) = 5x^2 + x^{1/2} - x^{-3}$$

2. Integrate each term using the power rule for integration:

1. Integral of $5x^2$: $5 \cdot \frac{x^{2+1}}{2+1} = 5 \cdot \frac{x^3}{3} = \frac{5}{3}x^3$
2. Integral of $x^{1/2}$: $\frac{x^{1/2+1}}{1/2+1} = \frac{x^{3/2}}{3/2} = \frac{2}{3}x^{3/2}$
3. Integral of $-x^{-3}$: $-\frac{x^{-3+1}}{-3+1} = -\frac{x^{-2}}{-2} = \frac{1}{2}x^{-2} = \frac{1}{2x^2}$

3. Add the constant of integration:

$$\int (5x^2 + x^{1/2} - x^{-3}) \, dx = \frac{5}{3}x^3 + \frac{2}{3}x^{3/2} + \frac{1}{2x^2} + C$$

Answer: $\frac{5}{3}x^3 + \frac{2}{3}x^{3/2} + \frac{1}{2x^2} + C$

Example 7: Definite Integrals and the Fundamental Theorem of Calculus

Problem: Evaluate the definite integral $\int_1^3 (2x + 1) \, dx$.

Analysis: The Fundamental Theorem of Calculus Part 2 states that if $(F(x))$ is an antiderivative of $(f(x))$, then $(\int_a^b f(x) \, dx = F(b) - F(a))$. We first find the antiderivative of $(2x + 1)$, and then evaluate it at the upper and lower limits of integration.

Solution:

1. Find the antiderivative of $(f(x) = 2x + 1)$:

The antiderivative is $(F(x) = x^2 + x)$.

2. Evaluate $(F(x))$ at the upper limit $(x = 3)$:

$$(F(3) = (3)^2 + 3 = 9 + 3 = 12)$$

3. Evaluate $(F(x))$ at the lower limit $(x = 1)$:

$$(F(1) = (1)^2 + 1 = 1 + 1 = 2)$$

4. Subtract the lower limit value from the upper limit value:

$$(\int_1^3 (2x + 1) \, dx = F(3) - F(1) = 12 - 2 = 10)$$

Answer: 10. This value represents the area under the line $(y = 2x + 1)$ from $(x = 1)$ to $(x = 3)$.

Applications of Calculus: Solving Real-World Problems

Calculus isn't just an abstract mathematical pursuit; it has profound real-world applications. Two common areas where calculus is applied are optimization and related rates.

Optimization Problems: Finding Maxima and Minima

Optimization problems involve finding the maximum or minimum value of a function, often within certain constraints. This typically involves finding critical points by setting the first derivative to zero and analyzing the second derivative to determine if it's a maximum or minimum.

Example 8: Maximizing Area of a Rectangular Pen

Problem: A farmer has 2400 feet of fencing and wants to fence off a rectangular field that borders a straight river. He needs no fence along the river. What are the dimensions of the field that has the largest area?

Analysis: We need to express the area of the rectangle as a function of one variable and then find its maximum. This will involve setting up equations for the perimeter and area, using one to eliminate a variable in the other, and then using calculus to find the maximum.

Solution:

1. Set up variables: Let (l) be the length of the side parallel to the river, and (w) be the width of the sides perpendicular to the river.
2. Formulate the constraint equation (fencing): The total fencing used is $(l + 2w = 2400)$.
3. Formulate the objective function (area): The area is $(A = l \cdot w)$.
4. Express the objective function in terms of one variable: From the constraint, $(l = 2400 - 2w)$. Substitute this into the area formula:

$$(A(w) = (2400 - 2w)w = 2400w - 2w^2)$$

5. Find the critical points: Take the derivative of $(A(w))$ with respect to (w) and set it to zero:

$$(A'(w) = 2400 - 4w)$$

$$(2400 - 4w = 0 \implies 4w = 2400 \implies w = 600)$$

6. Determine if it's a maximum: Use the second derivative test. $(A''(w) = -4)$. Since $(A''(600) = -4 < 0)$, this indicates a local maximum.
7. Find the dimensions: If $(w = 600)$ feet, then $(l = 2400 - 2(600) = 2400 - 1200 = 1200)$ feet.

Answer: The dimensions of the field that has the largest area are 1200 feet (parallel to the river) by 600 feet (perpendicular to the river).

Related Rates Problems: Connecting Rates of Change

Related rates problems involve finding the rate at which a quantity changes with respect to time, given the rates of change of other related quantities. These problems often involve implicit differentiation and the chain rule.

Example 9: The Ladder Problem

Problem: A ladder 10 feet long rests against a vertical wall. If the bottom of the ladder slides away from the wall at a rate of 2 ft/sec, how fast is the top of the ladder sliding down the wall when the bottom of the ladder is 6 feet from the wall?

Analysis: We can model this situation with a right triangle, where the ladder is the hypotenuse. We'll use the Pythagorean theorem and implicitly differentiate with respect to time to find the relationship between the rates of change.

Solution:

1. Set up variables: Let (x) be the distance of the bottom of the ladder from the wall, and (y) be the height of the top of the ladder on the wall. The length of the ladder is constant at 10 feet.
2. Formulate the relationship: By the Pythagorean theorem, $(x^2 + y^2 = 10^2 = 100)$.
3. Identify the given rates and what needs to be found:
 1. Given: $(\frac{dx}{dt} = 2)$ ft/sec (the rate at which the bottom slides away).
 2. To find: $(\frac{dy}{dt})$ (the rate at which the top slides down) when $(x = 6)$ feet.
4. Implicitly differentiate the equation with respect to time (t) :

$$(\frac{d}{dt}(x^2 + y^2) = \frac{d}{dt}(100))$$

$$(2x \frac{dx}{dt} + 2y \frac{dy}{dt} = 0)$$

5. Find the value of (y) when $(x = 6)$: Using $(x^2 + y^2 = 100)$, when $(x = 6)$, $(6^2 + y^2 = 100 \implies 36 + y^2 = 100 \implies y^2 = 64 \implies y = 8)$ feet (since height must be positive).
6. Substitute the known values into the differentiated equation:

$$(2(6)(2) + 2(8)\frac{dy}{dt} = 0)$$

$$(24 + 16\frac{dy}{dt} = 0)$$

7. Solve for $(\frac{dy}{dt})$:

$$(16\frac{dy}{dt} = -24 \implies \frac{dy}{dt} = -\frac{24}{16} = -\frac{3}{2}) \text{ ft/sec.}$$

Answer: The top of the ladder is sliding down the wall at a rate of $(-\frac{3}{2})$ ft/sec.
