7. Signature

Handwritten Signature:

If you are printing and mailing the letter, leave approximately four blank lines for your handwritten signature.

Typed Name:

Type your full name on the line below the blank space for your signature.

8. Typed Name

This is the typed version of your full name, placed below the space for your handwritten signature. It ensures

9. Enclosure(s) or Attachment(s) (Optional)

Indications:

10. CC (Carbon Copy) or BCC (Blind Carbon Copy) (Optional)

1. CC: Recipient(s) will be aware that others are receiving a copy.
2. BCC: Recipient(s) will **not** be aware that others are receiving a copy. BCC is typically used for email and is less common in traditional paper business letters.

Format:

Follow your typed name or enclosure notation with "CC:" or "BCC:" followed by the names of the individuals receiving copies.
