The fundamental idea is to represent the structure as an assembly of interconnected elements (beams, columns, trusses, etc.). Each element has its own stiffness characteristics, which relate the forces

and moments acting on it to the displacements and rotations at its nodes (connection points). The matrix method then assembles these element properties into a global stiffness matrix for the entire structure. This global matrix, along with the applied loads and boundary conditions, forms a system of linear equations that can be solved to determine the unknown displacements and forces throughout the structure.

Key concepts underpinning the matrix method include:

1. **Degrees of Freedom (DOF):** These represent the independent displacements and rotations that a structure or its components can undergo.
2. **Stiffness Matrix (K):** This matrix relates nodal forces and moments to nodal displacements and rotations. A higher stiffness value indicates a greater resistance to deformation.
3. **Force-Displacement Relationship:** The core equation often used is  $[F] = [K][\Delta]$ , where  $[F]$  is the vector of nodal forces,  $[K]$  is the stiffness matrix, and  $[\Delta]$  is the vector of nodal displacements.
4. **Load Vector (P):** Represents the external forces and moments applied to the structure.
5. **Boundary Conditions:** These define the constraints on the structure, such as fixed supports or pinned connections, which dictate which degrees of freedom are zero.

## The Two Primary Approaches: Stiffness and Flexibility

The matrix method of structural analysis primarily manifests in two distinct yet complementary approaches: the stiffness method and the flexibility method (also known as the force method).

## The Stiffness Method (Displacement Method)

The stiffness method is arguably the more prevalent and computationally efficient approach, especially for modern computer-aided analysis. Its core principle is to express the equilibrium of the structure in terms of unknown nodal displacements. The process involves:

1. **Discretization:** Dividing the structure into finite elements.
2. **Element Stiffness Matrix:** Developing the stiffness matrix for each individual element. This matrix describes how the element responds to forces and moments at its nodes.
3. **Assembly:** Combining the individual element stiffness matrices to form a global stiffness matrix for the entire structure. This process ensures that compatibility of displacements at the nodes is maintained.
4. **Load Vector Formation:** Creating a vector of all external forces and moments acting on the structure.
5. **Boundary Conditions Application:** Incorporating the constraints of the structure (e.g., fixed supports).
6. **Solving for Displacements:** Solving the system of linear equations  $[P] = [K][\Delta]$  for the unknown nodal displacements  $[\Delta]$ .
7. **Calculating Member Forces:** Once the nodal displacements are known, the forces and moments within each structural member can be calculated using the element stiffness matrices.

The stiffness method is particularly well-suited for indeterminate structures, where the number of unknowns exceeds the number of equilibrium equations. Its systematic nature makes it highly amenable to computer programming.

## The Flexibility Method (Force Method)

In contrast, the flexibility method focuses on unknown forces or

moments within the structure. It starts by formulating a **primary structure** – a statically determinate structure obtained by removing some restraints or internal members from the original structure. The process is as follows:

1. **Redundancy Identification:** Identifying the redundant forces or moments that need to be solved for.
2. **Primary Structure Selection:** Creating a statically determinate primary structure.
3. **Flexibility Matrix:** Determining the flexibility matrix of the primary structure. This matrix relates nodal displacements to nodal forces. A higher flexibility value indicates greater displacement under a unit load.
4. **Compatibility Equations:** Formulating compatibility equations that ensure the deformations in the primary structure are consistent with the original structure's constraints. These equations are expressed in terms of the unknown redundant forces and the known flexibility characteristics.
5. **Solving for Redundants:** Solving the system of compatibility equations to determine the values of the redundant forces and moments.
6. **Calculating All Forces:** Once the redundant forces are known, the forces and moments in all parts of the original structure can be determined by superposition.

While the flexibility method can be insightful for understanding force flow, it often leads to larger systems of equations than the stiffness method for complex indeterminate structures, making it less computationally efficient for routine analysis.
