2. **Advantages:** Fast random access (getting elements by index) using `get(index)`.
3. **Disadvantages:** Slow insertion and deletion of elements in the middle of the list because elements need to be shifted. Also, resizing the underlying array can be costly.

2. `LinkedList`:

10. What is the difference between `HashMap` and `TreeMap`?

Both implement the `Map` interface but differ in their ordering and performance:

1. `HashMap`:

1. Stores key-value pairs using a hash table.
 2. Does not maintain any specific order of elements. The order can even change over time.
 3. **Performance:** Generally offers $O(1)$ average time complexity for `put()` and `get()` operations, assuming good hash function distribution. In the worst case (many hash collisions), it can degrade to $O(n)$.
2. **TreeMap**:
1. Stores key-value pairs in a red-black tree structure.
 2. Maintains elements in ascending order of keys (natural ordering or based on a provided Comparator).
 3. **Performance:** Offers $O(\log n)$ time complexity for `put()` and `get()` operations.

When to use which:

1. Use `HashMap` when you need fast access to elements and don't care about the order.
2. Use `TreeMap` when you need elements to be sorted by key, allowing for operations like retrieving the smallest/largest key or iterating in sorted order.

Robust error handling is crucial for creating stable applications. Java's exception handling mechanism helps manage runtime errors gracefully.

11. What is the difference between checked and unchecked exceptions?

Exceptions in Java are broadly categorized into two types:

1. **Checked Exceptions:**
 1. These are exceptions that the compiler forces you to handle. If a method can throw a checked exception, it must either catch it or declare it using the `throws` keyword.
 2. They typically represent external conditions that are beyond the control of the program (e.g., file not found, network issues).
 3. Examples: `IOException`, `FileNotFoundException`, `SQLException`.
2. **Unchecked Exceptions (Runtime Exceptions):**

Why the distinction? The compiler's requirement to handle checked exceptions encourages developers to consider and prepare for potential external failures, leading to more resilient code.

12. What is the `try-catch-finally` block? Explain its purpose.

This is the core construct for exception handling in Java.

1. **`try` block:** Contains the code that might throw an exception.
2. **`catch` block:** Catches a specific type of exception thrown from the `try` block and provides a way to handle it. You can have multiple `catch` blocks for different exception types.
3. **`finally` block:** Contains code that will always execute, regardless of whether an exception occurred or not. This is ideal for cleanup tasks like closing resources.

Purpose: To separate normal program flow from exceptional program flow. It allows you to recover from errors or at least log them gracefully without crashing the application.

13. What is the `throw` vs. `throws` keyword in Java?

16. What is `synchronized` keyword in Java?

The `synchronized` keyword is a crucial tool for managing concurrent access to shared resources in multithreaded applications. It ensures that only one thread can execute a block of code or a method at a time, preventing data corruption and race conditions.

How it works:

1. **Synchronized Methods:** If a method is declared as `synchronized`, the lock for the current

object instance (`this`) is acquired before the method execution. Other threads attempting to call any synchronized method on the same object instance will be blocked until the first thread releases the lock (when it exits the method).

    count++; // Critical section  
}
```

2. **Synchronized Blocks:** You can synchronize specific blocks of code within a method. This allows for finer-grained control over which parts of the code are protected. You specify an object on which to acquire the lock.
